RECOMMENDATION

THAT the Council of the Corporation of the Township of Wellington North receive report DFC 2021-005 Appointment of Fire Department Deputy Chief;

AND FURTHER THAT Council appoint Callise Loos as Deputy Chief of the Wellington North Fire Services.

AND FURTHER THAT By-law 054-18 being a by-law to appoint a Deputy Fire Chief be repealed.

AND FURTHER THAT the Mayor and Clerk be authorized to execute the by-law.

PREVIOUS PERTINENT REPORTS/BY-LAWS/RESOLUTIONS

BACKGROUND

As part of the transition to the new Management Team for fire services in Minto and Wellington North, Deputy Chiefs should be appointed to act on behalf of the Director of Fire Services in his absence. This includes all of the day to day operations of the fire department and other associated activities and duties of the Fire Chief.

The 2 Deputy Chiefs, Callise and Marco, are better equipped to run the day to day operations as they already cooperate in most of the activities. Anything to do with emergency scene operations can be run by the District Chiefs in each station as well as the other officers. The Management team will be there to support them whatever their needs including incident command capabilities if needed. Marco has already been appointed a Deputy Chief for Wellington North by By-law 054-18, so will only need to be added in Minto.

This report and by-law will be going to each municipality to ensure we are meeting the requirements of the Fire Protection and Prevention Act. It will name the same personnel for each department as Deputy Chiefs so the continuity across both organizations still exists. It would be very difficult to put the District Chiefs in the position of acting fire chief when they are doing their full time jobs on a day-to-day basis and not familiar with administrative daily activities.

By passing this by-law, it will ensure the efficient operations of both departments carry on throughout any absences. Continuity of operations on the administrative side is just as important as continuity on the response side of the departments. All of the Chiefs will continue to work together as an administrative team to ensure all aspects of the department are where they need to be.

PREVIOUS PERTINENT REPORTS/BY-LAWS/RESOLUTIONS

DFC 2021-004 Fire Service Modernization Report

BACKGROUND

Previously, Guelph Fire has provided Wellington North Fire Services with dispatching services on a paging only service. This means that they would receive all of our 911 calls and dispatch us to the incident. Once we acknowledged the call, they would stop monitoring us. We were then on our own for any dispatching needs.

In this year's budget, we purchased new radios to join all of the other fire services and public works departments on the Wellington County radio system. Once implemented later this month, we will be able to reliably talk to Guelph from an incident scene. This will allow us to proceed with a full dispatching agreement with Guelph. All other fire departments in Wellington County presently use full dispatching services with Guelph Fire. Utilizing full time dispatching services is standard practice in most fire services and ensures you always have someone on the incidents to be able to perform all of the functions needed.

Presently as mentioned, we rely on a dispatcher to be in our radio room all of the time. With the varying numbers we have attending our calls, we don't always have a person to put in the radio room to complete this important task. By signing a full dispatch agreement with Guelph Fire, we will always have a fully trained dispatcher able to assist us on out calls

FINANCIAL CONSIDERATIONS

Our dispatch contract will increase by approximately \$8000, but savings in other areas of the department should offset this increase in the budget.

BY-LAW NUMBER 099-21

BEING A BY-LAW TO CONFIRM THE PROCEEDINGS OF THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WELLINGTON NORTH AT ITS REGULAR MEETING HELD ON OCTOBER 12, 2021

That the Mayor and the proper officials of the Corporation of the Township of Wellington North are hereby authorized and directed to do all things necessary to give effect to the action of the Council of the Corporation of the Township of Wellington North referred to in the proceeding section hereof.
- 3. The Mayor and the Clerk are authorized and directed to execute all documents necessary in that behalf and to affix thereto the Seal of the Corporation of the Township of Wellington North.
