NOTICE OF ROAD CLOSURE - UPDATE

Please be advised that the current road closure, of Queen Street East (Hwy. #89) in Mount Forest, from Main Street (Hwy #6) to Ayrshire Street, is now expected to continue until **September 30, 2022**. The existing signed detour routes will remain in effect until that time. Note that the Hwy #89 westbound lane is actually closed east of Mount Forest at Concession 6 N, to help ensure truck traffic follows the established signed detour routes. There will be periods of time when there will be no access to driveways for properties that front along the construction limits. There may be restricted access for emergency vehicles to properties during the construction period.

The attached figures illustrate the general limits of the Queen Street East Reconstruction project and the detour routes that are current in effect until **September 30, 2022**.

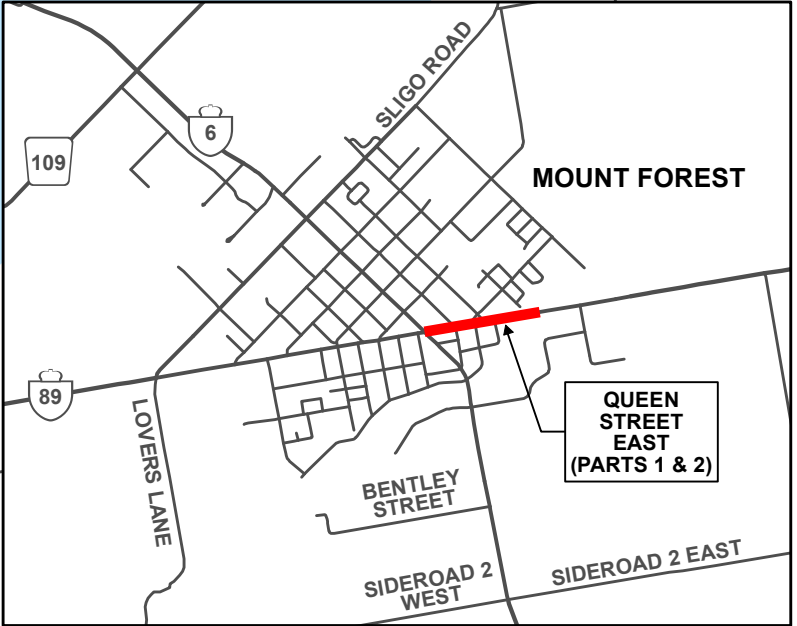
