<b>THE AMENDMENTS ARE LOCATED</b> in Pt of Pk Lots Q & R, McDonalds's Survey; Pt of Divisions 3 & 4, WOSR (formerly Arthur Twp.) shown as Pt 1 on Reference Plan 61R-7881; also Pt of Hannah St., Allan & Geddes Survey, shown as Pt 2 on Reference Plan 61R-7881, Mount Forest, now Township of Wellington North. The lands have frontage on Highway 6 and Bentley Street.	
<b>THE PURPOSE &amp; EFFECT OF THE COUNTY OFFICIAL PLAN AMENDMENT</b> is to redesignate the subject property from Industrial and Greenlands to Residential and Highway Commercial. The applicant is proposing to develop the lands with a residential subdivision which will include a variety of housing types, commercial area, some retail uses and an open space area. The amendment affects Schedule A1 – Mount Forest and there will be proposed textual changes to the policies of the Official Plan.
