In the minutes of the February 2, 2021 meeting, staff were directed to bring a report to the March 2, 2021 Recreation, Parks and Leisure Committee on the operational costs and maintenance required for a clay infield baseball diamond. The staff report was not included on the agenda, as staff required another month to research and discuss plans with the Donald Family. This report will be included on the April 6, 2021 Recreation, Parks and Leisure Committee Agenda.

Business Arising From Minutes

Staff shared the revised colour scheme with the President of the Arthur OptiMrs Club. Overall, the response they received from club members regarding the colours was positive.

The Community Recreation Coordinator, President of the OptiMrs Club and Stephen Van Meer of Park N Play met on site Friday, February 26, 2021. During this site visit, Stephen noted that the playground area is approximately two feet below grade, contributing to drainage issues.

The OptiMrs Club is exploring the possibility of adding an accessible ramp to their pavilion. However, this may not be necessary once the playground is installed and the site is rehabilitated.

Park N Play are currently projecting that the project will be completed at the end of May 2021, provided there are no interruptions caused by weather and provincial regulations.

Arthur Arena Floor (Verbal Update)

The Director of Operations has contacted various engineering firms for support on the upgrades of the Arthur Arena Floor. The initial plan was for an engineering firm to submit a design and hire contractors to complete the project. Unfortunately, there has not been any interest from engineering firms to complete this project. As a result, staff have connected with a local contractor and requested a quote for the completion of the project. As time is of the essence, staff explained that this quote, if within budget, will be sent directly to Council for consideration. The name of the local contractor was not disclosed to Committee.

The Recreation Services Manager has had discussions with the Arthur Minor Lacrosse Association to ensure they are aware of the project and to make provisions for their needs.

2. PerfectMind Recreation Software Demonstration

The Community Recreation Coordinator and Administrative Assistant provided a demonstration on the PerfectMind booking and registration software, from a customer and staff perspective.

March 1, 2021 was the official "Go Live" date for the Recreation booking and registration software. As of this date, staff no longer use CLASS to view facility bookings, review contracts and view monthly calendar events. Township customers can now check facility availability, request to book a space, register for a program, view their families schedule of activities, and pay invoices online. Marketing of the platform will begin in two weeks' time. This soft launch will provide the recreation team with additional time to work in the "live" environment, and address any anomalies, before it is widely promoted.

New Business/Roundtable

Draft Mount Forest Agricultural Society Agreement

The draft agreement was recently shared with members of the Mount Forest Agricultural Society.

As written, the new Agreement would end on August 17, 2024, aligning with the Mount Forest Victory Church Agreement. Following the end of the first term, the

agreement would be renewed for an additional four years, ending on December 31, 2028.

The Agreement provides additional clarification regarding the responsibilities of the Township and the Society and further outlines the ownership of certain buildings and structures.

Parking remains a concern for both the Township and the Society. Committee expressed optimism that the parking challenges can be resolved through this agreement.

The Society will be invited to the April 6, 2021 Recreation, Parks and Leisure Committee meeting to discuss the agreement.

BETWEEN

THE CORPORATION OF THE TOWNSHIP OF WELLINGTON NORTH hereinafter referred to as "Wellington North"

OF THE FIRST PART

-and-

THE MOUNT FOREST AGRICULTURAL SOCIETY hereinafter referred to as "the Society"

OF THE SECOND PART

Whereas Wellington North is the owner of the lands and the Society wishes to use the said lands from time to time.

The parties to this agreement agree as follows:

1. Term of Agreement

- a. The term of the Agreement shall be for three (3) years, commencing on April 1, 2021 expiring on August 17, 2024.
- b. Provided that the Society is in good standing under this Agreement, the Agreement shall be renewed with each term of Council on a four-year term. The next agreement will commence August 18, 2024 and will expire on December 31, 2028.

2. Use of Facilities

- a. The Society may use the Mount Forest & District Sports Complex, located at 850 Princess Street, Mount Forest, fifteen (15) days per calendar year, at no cost to the Society.
- b. The Society may use the Mount Forest Victory Church, located at 320 King Street, Mount Forest, five (5) consecutive days per calendar year as per the Lease Agreement between the Township of Wellington North and the Mount Forest Victory Church, at no cost to the Society.
- c. The Society may at all times, use the storage room in the southerly or rear portion of the Mount Forest Victory Church, located at 320 King Street, Mount Forest as per the Lease Agreement between the Township of Wellington North and the Mount Forest Victory Church, at no cost to the Society.

3. Buildings and Property

- a. It is understood and acknowledged the Society owns the following:
 - i. Announcer Stand
 - ii. Office
 - iii. Sale Barn

- iv. All wood fences
- v. All Bleachers (beside Announcer Stand/Facing the Track)
- b. The Township of Wellington North owns:
 - i. All of the Land and buildings at 320 King St E, except as listed in clause 3 a)
- c. And further that in the event the agreement is terminated, the Society has one year to remove, at their own expense all of the property owned by them.
- d. Should the property not be removed within the time frame, the municipality may dispose of it as they deem fit.

4. Responsibilities of the Society

- a. Provide year-round insurance coverage on the buildings and property identified in clause 3 a) naming the Wellington North as co-insured.
- b. Maintain all buildings and property identified in clause 3 a) in a state of good repair.
- c. Maintain the Western Horse Show Ring in a state of good repair.
- d. Maintain hydro costs incurred by the Society.
- e. The Society will make best efforts to ensure that parking is contained to the parking lot off King Street.
- f. The Society will not lease or sublet the property or buildings without prior written consent from Wellington North.
- g. The Society shall ensure that any events:
 - i. adhere to the Township's Alcohol Risk Management Policy
 - ii. receive written permission from Wellington North for all events serving alcohol.

5. Responsibilities of Wellington North

- a. Maintain the sports fields, splash pad, playground, and parking lots.
- b. Insurance coverage for the property

6. Termination

a. This lease may be terminated by either party with one year's written notice. Township of Wellington North







RECOMMENDATION

THAT the Recreation, Parks and Leisure Committee receive for information Report RPL 2021-005 being a report on the Mount Forest Optimist Baseball Diamond Jim Donald Donation.

PREVIOUS PERTINENT REPORTS/BY-LAWS/RESOLUTIONS

February 2, 2021 Jim Donald made a Deputation to Recreation, Parks and Leisure Committee

BACKGROUND

At the February 2, 2021 Recreation, Parks and Leisure Committee meeting, the Committee received a deputation from Jim Donald regarding the Mount Forest Optimist Baseball Diamond.

Mr. Donald explained that he would like to renovate the Optimist Diamond infield, switching it from a stone dust infield to a granular red clay surface. The cost of the renovation would be covered by the Donald Family. In recognition of this financial commitment, the family would like the Township of Wellington North to consider naming the facility the Donald Softball Field for a period of 20 years.

At this time, it is difficult for staff to comment on the project scope and financial commitment as we have not received quotes back from Mar-Co Clay. Mr. Donald has also reached out to a local landscape company to receive pricing on the removal of the existing stone dust and the installation of tile drain in the infield.

Staff are considering two options for the excess stone dust:

- 1. The stone dust would be used to top-up the other baseball diamonds in Mount Forest.
- 2. The stone dust would be used to top-up the Optimist Diamond parking area and track around the fairgrounds.

The Recreation Services Manager, Community Recreation Coordinator and Mount Forest Lead Hand have met three times onsite with Scott Corrigan of the Mount Forest Minor Baseball Association and Jim Donald to discuss the proposed plans. During these discussions, a timeline of September/October 2021, was suggested for the works to be completed. The Township of Wellington North currently has a Diamond Groomer from Bannerman which can be used on a stone dust and clay infield. Additional training will be required for full time and part time staff on how to maintain a clay diamond.

A representative from Mar-Co Clay informed staff, Mr. Corrigan, and Mr. Donald that a top-up of clay will be required in the spring of 2022, if work proceeds in the fall of 2021.

The Mount Forest Minor Baseball Association is discussing options around upgrades to the dug-outs and players area.

Staff suggest that a subsequent report come back to committee, when additional information has been received, to provide Committee with a clear project scope.

FINANCIAL CONSIDERATIONS

At this time, it is unclear what the total financial implications will be as staff are waiting on quotes from service providers.
