### PREVIOUS REPORTS PERTINENT TO THIS MATTER

Report CLK 2016-059 being a report regarding a petition for drainage works under the Drainage Act on part Lot 5, Concession 11 (formerly Arthur Township

#### BACKGROUND

Council passed a motion at the September 26, 2016 meeting, approving drainage works under the *Drainage Act* on Part Lot 5, Concession 11 in the Township of Wellington North, formerly Arthur Twp. and appointed K. Smart Associates Limited to prepare a report on the work to be undertaken.

An on-site meeting was held on August 15, 2017 to scope local drainage issues and to hear concerns of impacted landowners. On February 15, 2018 a public meeting was held with impacted landowners to review the process, the watershed boundary, the proposed work and landowner costs related to the project.

The final engineers report was submitted by K. Smart Associates Limited on April 13, 2018 and copy is available in the Clerk's office at the Township of Wellington North. Additonally all impacted landowners, plus agencies were circulated with a copy of the report.

The engineering report indicates the work will consist of the excavation of 214m of open drain (including the incorporation of 39m of ditch and 15m of culvert across Sally Street), the installation of a 9m long laneway culvert and the installation of 23m of closed drain.

The estimated cost of the project is \$68,100.00.

Pursuant to the *Drainage Act*, the report was circulated to impacted landowners and agencies within 30 days of receipt of the report and a notice was provided advising landowners and agencies the date, time and location of the meeting at which the report will be considered.

Pursuant to the Act, Council must approve the engineer's report and adopt a provisional by-law by first and second reading or not approve the report and provide the reasons for their decision.

If Council approves the work, a Court of Revision will be held on Monday June 4, 2018 at 2:00 pm, at which landowners may appeal their assessment. All landowners who are affected must then be advised of any revisions and provisions for further appeals.

After the appeal process has expired, the by-law will be given third reading, the process for construction of the drainage works can begin and benefitting landowners and road authorities will be assessed costs in accordance with the approved engineer's report.

### FINANCIAL CONSIDERATIONS

The municipality has been assessed \$24,831.00 for work on Sideroad 3 West and Sally Street.

2018 Municipal Drain Budget reflected Township Share of Drain Maintenance Expenses of \$24,850. Year to date expenses are \$31,599.

## **BY-LAW NUMBER 044-18**

## PROVISIONAL DRAIN REPAIR BYLAW

**BEING** a Provisional Drain Repair By-law to provide for the construction of the Cormack Drainage Works.

**WHEREAS** the Township of Wellington North is required to undertake such repairs in accordance with Section 74 and Section 75 of *The Drainage Act*, R.S.O. 1990.

**AND WHEREAS** the work to be done is: excavation of 214m of open drain (including the incorporation of 39m of

ditch and 15m of culvert across Sally Street),

installation of a 9m long laneway culvert

installation of 23m of closed drain.

AND WHEREAS the estimated cost of such repairs is: \$68,100.00

**AND WHEREAS** the costs of the repairs shall be assessed against all lands and roads in the watershed upstream of the point of commencement of the repair work being done, prorata with the last revised Schedule of Assessment for the respective drain;
