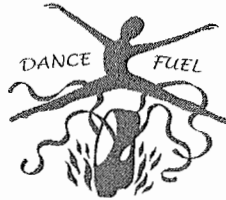

Dear Mr. Lavers;

As per our tel-econ, I have some parents with children that drive from Arthur to Grand Valley weekly to participate in dance classes at the Grand Valley & District Community Centre. They have repeatedly asked that I come out to Arthur to hold classes as a convenience to them. Pending interest, as there must be enough little dancers to make it worth while, I would like to use the room upstairs at the Arthur Arena to hold classes for 2 or 3 hrs one evening a week until the end of May, 2016 when we break for summer after our recitals. I am currently advertising the possibility of classes starting for Arthur residents and based on the feed back I receive over the next couple of weeks, will determine if I can accommodate the families who have expressed interest. I anticipate there will be some positive response, but there may in fact be insufficient students to make it worth while after paying the instructors and rent. That being said, because we are a very small, laid back studio and the fact that there are no fancy mirrors and ballet barres at the facilities I use, my fees are well below other studios and thankfully the current locations I am using in Grand Valley, Shelburne and Dundalk realize that and charge me only \$30-\$35 (+HST) per evening. If your organization would be willing to do same it would be greatly appreciated! I am fully insured for our little dance school through the Co-Operators and can provide proof of such. Hopefully we can come to an amicable agreement and there are enough interested families in the community to provide this service to them for their convenience. Please let me know as soon as possible so that I can confirm with those who have already pre registered on line that this will really happen this year! At this juncture, Thursdays would work best, and we would be looking at perhaps 5:30pm to 7:00pm or 8:00pm depending on the number of classes I can put together, and the commuting schedule of the parents.

PREVIOUS REPORTS PERTINENT TO THIS MATTER

BACKGROUND

Mount Forest Diamond Groomer

\$7,000 was approved within the 2015 capital program for this project.

Unit was purchased and commenced service in May 2015 at a cost of \$6,561 from Bannerman Inc.

Mount Forest Ball Diamond Fencing

\$6,000 was approved within the 2015 capital program for this project

Fencing repairs will commence in late September 2015 when baseball season is completed. Multiple quotes were solicited as per the Township's Purchasing and Procurement Policy but only a single quote was received. Quotation from B.L Farm Services is attached.

Mount Forest Water Treatment System

\$5,400 was approved within the 2015 capital program for this project. Quotation received from Custom Blended Treatments Ltd (attached) is for \$5,891.52. In the report there was a recommendation for caulking on various exterior control joints to be replaced and this work was completed in August 2015.

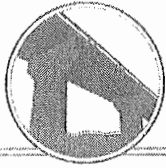

RE: Arthur and Area Community Centre – Structural Review

On June 3, 2015, Andrew Ross, P.Eng., reviewed the structure of the Arthur and Area Community Centre and the Aquatic Centre. The review was limited to the structure of the building and no mechanical or electrical services were reviewed. The structural review was limited to the publicly occupied building and we did not review structures of ancillary components such as pipe racks or storage shelves. The inspection was assisted by the use of a hydraulic lift that provided hands-on access to the roof trusses over the arena.

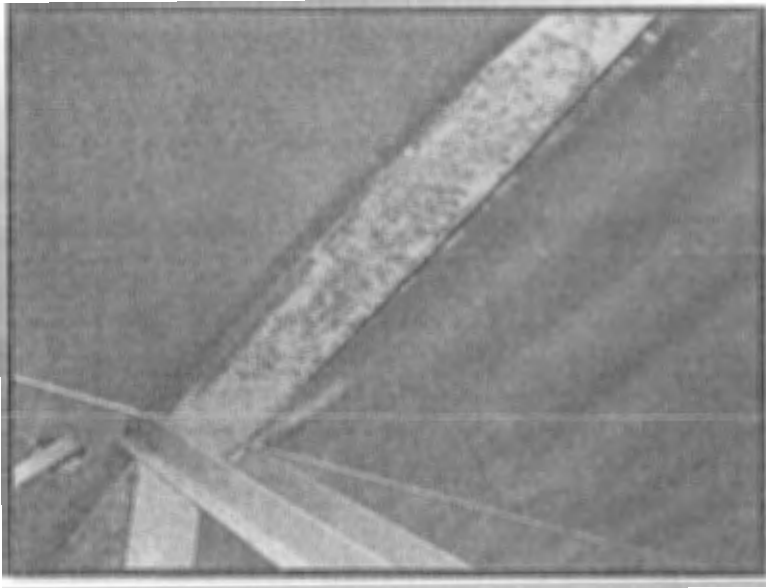
The main Community Centre was built in 1978 and was architect designed. The aquatic centre was built in 2005 and also had professional designs completed. From these dates, it has been assumed that the buildings were designed for live loads from the 1976 or later versions of the building code. No structural analysis was done for any building component. The inspection was aimed at identifying areas of deterioration as compared to the probable as-constructed condition.

The Community Centre was previously reviewed by professional engineers in 1993, 1998 and 2006. The Aquatic Centre was built under designer review in 2005. There have been maintenance works done such as painting or roofing membranes, but no significant rehabilitations have been made to the building.

Arena Roof

The arena roof is framed with steel trusses at close spacing so the deck spans between trusses without purlins. The underside of the galvanized steel deck shows some stains of condensation and there were some isolated spots of rust. A reflective membrane between the trusses makes it difficult to view the decking. We were able to make close-up spot inspections but could not do an over-all inspection of the roof deck.

The steel trusses have some minor localized rusting. The bottom chords have been re-coated but the top chords appear to have the original paint and are in worse condition. However, this deterioration is superficial and is not yet significant to the structure. Typically, the corrosion is the result of high humidity levels over the ice. The bottom chords of the trusses are not straight and have some lateral misalignment. This was noted in previous reports and is likely the as-constructed condition. Especially noteworthy is the 4th truss from the north end.

The trusses of this roof, and over the community centre, were designed with the bottom chords to be attached, as braces, to the masonry walls. This type of design is now discouraged because of stresses induced in the walls. However, no cracks were observed in the walls.

Hall and Ancillary Rooms

The change rooms, washrooms, utility rooms, upper hall and other ancillary rooms were reviewed for deflections, cracks or other deficiencies. No significant problems were observed.

The community centre hall and adjoining rooms were reviewed and no structural deficiencies were observed.

Some stepped cracks were visible in the masonry where some minor settlement or contraction has taken place. These were noted for comparison with the next inspection. None were significant enough to warrant a repair.

Exterior

The exterior of the walls and the roof were observed. Cracked masonry, previously reported, had been repaired. The roof membrane shows one area of blistering near the southeast corner. This is a symptom of aging, but staff did not report any leaks yet.

The control joints in the exterior masonry have aged, hardened, and cracked. This will allow water to the interior of the wall which can cause damage. Maintenance replacement of the caulking is recommended.

Aquatic Centre

The low-level addition at the south end of the arena contains the Aquatic Centre. Its construction is similar with structural masonry walls and precast concrete roof slabs. The roofing membrane appears to be a built-up membrane, coated in granular ballast. All structural components appeared to be in good condition.

Recommendations

The most common method to prevent rusting of the trusses over the arena is to provide dehumidification. We understand that a new dehumidifier has been recently purchased and is awaiting installation.

The exterior face of the masonry walls has a number of control joints to prevent stress cracks. These joints are sealed with a flexible caulking that has dried out and cracked with age. These joints should be cleaned out and re-caulked with a new flexible sealant.


Otherwise, we did not observe any structural deficiencies that require repair within the next five years. It is recommended that the building be reviewed again in 2020.

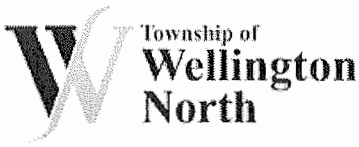
