**Original Paragraph (delete)**

The Tender deposit shall be in the form of a certified cheque, digital bid bond or scanned paper bid bond, payable to the Township of Wellington North. If Tender submissions are emailed, the Tender deposit is to be scanned and included with the Tender. The original copy may be required to follow within 48 hours of the Bid Closing Time and Date.”*

*“Item 2. Tender Deposit:  
If a digital bid bond or scanned paper bid bond is submitted, an Agreement to Bond must be completed and submitted as part of the Tender Submission (as described in 3. Contract Security). If the bid bond and Agreement to Bond are submitted in digital format, access and authentication information must be provided as part of the Tender Submission.”*
