

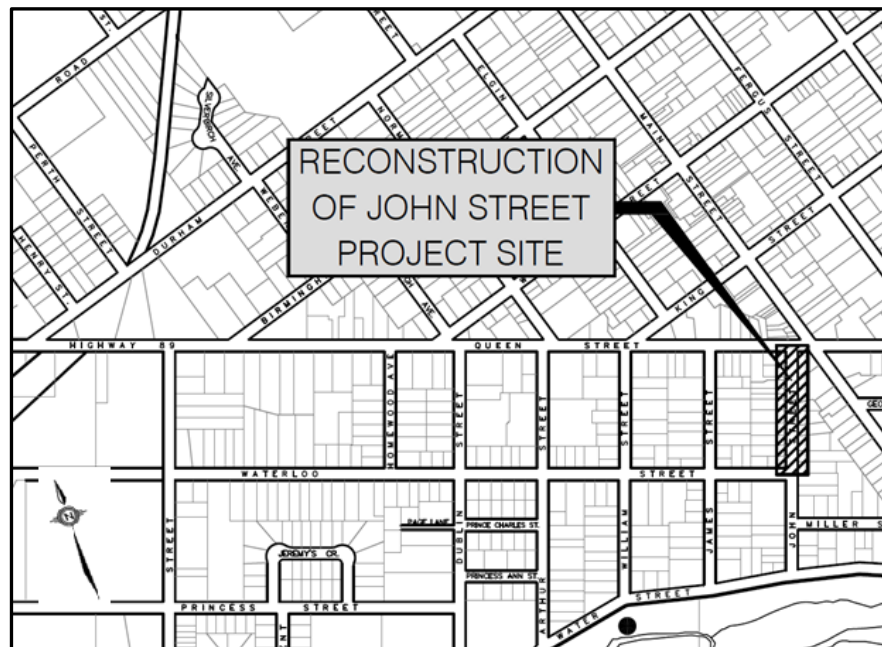

JOHN STREET (MOUNT FOREST) NOTICE OF CONSTRUCTION AND ROAD CLOSURE

April 30, 2025

The Township of Wellington North's Contractor, Moorefield Excavating Ltd of Harriston, Ontario, has been busy preparing for the full reconstruction of John Street, between Queen Street West (Highway 89) and Waterloo Street (see below key plan). Moorefield Excavating Ltd. expects construction to commence the week of May 20th, 2025, and will continue until the end of August 2025. John Street, within the identified limits, will be closed to through traffic during the construction period. Temporary closure of the intersection with Waterloo Street may be required for short durations throughout the construction period and advance notice of the temporary closure will be advertised on the Township website. Local and emergency access will be maintained throughout construction; however, access to driveways will be interrupted at various times during this period.

Reconstruction will include full replacement of the watermain, sanitary sewer, storm sewer, roadway, sidewalk, driveway entrances, and tree removals. New water, sanitary and storm services will also be installed to property line for residences on John Street. We would like to meet with you to discuss the location of the proposed storm service that will work best for your house.

Due to the nature of the construction, the Contractor is required to perform a pre-condition survey on the structures and buildings located within the construction limits (i.e., John St, between Queen St W and Waterloo St). A Sub-Contractor (Englobe) will be in contact with you to set up an appointment to inspect your property.

Properties with sump pumps will be required to connect to the new storm services as per standard drawing S2 (see back of this page). Township will reimburse homeowners up to \$250. Refer to By-Law No. 094-16 for more information as found at <https://www.wellington-north.com/sites/default/files/2021-12/sewer-connection-by-law-094-16.pdf>).

Moorefield Excavating Ltd. will be installing temporary watermain for water supply to your property during the construction period. The pipe proposed for this use will be installed on the existing ground with a pipe connected to your existing water service at property line. This temporary water system will be fully tested to meet Provincial and Municipal Standards before it is placed into operation. It will be monitored and tested regularly throughout the construction period.

Regarding garbage and recycling: On your designated waste and recycling collection days, please put your bags and recycling boxes at the standard roadside pick-up location by 7 a.m. Construction staff will pick them up and move them to a designated pick-up location as coordinated between Moorefield Excavating Ltd. and the County of Wellington Solid Waste Services Division. Moorefield Excavating Ltd. will return your recycling boxes to your property. Please ensure your recycling boxes are clearly marked with your civic address.

Regarding Canada Post mailbox modules: Canada Post will be temporarily relocating the existing mailbox modules currently located in front of House No. 361 John Street to in front of House No. 385 John Street on Waterloo Street. The mailbox modules will be reinstalled in front of House No. 361 following completion of construction activities.

Properties with private property (i.e., gardens, fences, other landscaping items, etc.) located within the public right-of-way are required to remove these items from the public right-of-way, by your own forces, prior to the start of construction and relocated onto private property. Public right-of-way is to be clear and free of private property items as identified above.
