Staff informed the committee that there has been no correspondence from the province regarding the Community Sport and Recreation Infrastructure Fund application, which was submitted earlier this year for approximately \$2.7 million (50% of the project cost). As of April 28, the fund is still accepting applications, and no announcements have been made by the province. With the provincial and federal elections now complete, staff are hopeful that announcements will be made soon and remain optimistic about receiving good news.

Chair Burke also shared optimism about the grant, noting that meetings with the Ministry of Tourism, Culture and Sport at the AMO Conference and ROMA Conference were well received, with Ministry representatives showing interest and engagement in the conversation.

The committee briefly discussed other grant possibilities, and staff reported that they are continuously seeking grant opportunities for this project

### **BACKGROUND**

Following the April 29, 2025 Mount Forest Aquatics Ad-Hoc Advisory Committee Meeting, staff were asked by the committee to create a draft of a newsletter to be distributed to the community, similar to the one recently distributed by the Louise Marshall Hospital Foundation.

Using the model of the Hospital Foundation newsletter, staff created a draft that included information about the new Mount Forest Outdoor Pool, highlights of recent donations, quotes from supporters of the project, information on how to purchase Mount Forest Pool Swag, and more. This newsletter would be 11" by 17" in size, double sided and folded in the middle to produce a four-page newsletter.

The first draft of the newsletter was reviewed by the Fundraising Sub-Committee at its meeting on June 10. Following that meeting, it was suggested in email correspondence amongst committee members that alternate delivery methods be investigated and quotes obtained.

Staff investigated printing and distribution options for the newsletter, which are summarized below. Detailed breakdowns of each option via Canada Post are included in this report as Attachment A. Wellington Advertiser prices are from their 2025 rate card.

All prices include taxes and other fees, unless otherwise noted.

Below are some things to consider for each delivery method.

#### Canada Post

Canada Post delivers to each and every mailbox within a specified area, and delivery can be targeted to specific postal codes and delivery routes. This includes apartment buildings, businesses, farms and residential areas. Residents typically review all pieces of mail in their mailbox.

### Wellington Advertiser/North Wellington Community News

Both publications have high circulation (great reach) and is delivered weekly to homes. Several residents report that they have not received the paper at their home in weeks or even months due to a lack of carrier. There is also a certain segment of the population who don't even open the paper when they receive it (i.e. it goes straight in the blue box).

It should be noted that the Wellington Advertiser expressed interest in a potential in-kind sponsorship when staff asked for a quote.

### Biz Bull

As a monthly publication, the Biz Bull tends to have a longer "on table" life than other publications. Has a high circulation (12,200), and is delivered to every mailbox in Wellington North, as well as Conn, Holstein, Varney and all of Minto. It should be noted that the Biz Bull has also offered to publish a monthly project update (to be curated by the Committee) free of charge.

Another method that staff suggest being used, in addition to print, is having the newsletter available on the Mount Forest Pool Build social media channels and on the Mount Forest Outdoor Pool page on the Township website. That way, this newsletter can be shared with residents and other interested parties outside of the mentioned distribution areas.
